Application for a Permit Under the Provisions of the Environmental Management Act

We, West Fraser Mills Ltd. DBA as Quesnel Sawmill Division and West Fraser Mills Ltd. DBA as Westpine MDF (West Fraser) at 1250 Brownmiller Road, Quesnel, BC V2J 6P5 and 300 Carradice Road, Quesnel, BC V2J 5Z7, intend to submit applications to the Director to authorize the discharge of a combination of fly and bottom ash onto agricultural fields around Quesnel, BC. The blended ash originates from West Fraser's Quesnel Sawmill and Westpine MDF's energy systems (Waste Authorizations 7512 and 13444 respectively).

The land upon which the facilities are situated are:
